Dear Screening Summit Participants,



Welcome to the American Cancer Society National Lung Cancer Roundtable's (NLCRT) Summit: ***Accelerating Uptake of Lung Cancer Screening – A National Initiative***. We hope your travels to Washington, DC, were smooth, and that you come ready to roll up your sleeves and work together to develop the foundation for a comprehensive strategic plan with actionable recommendations to accelerate the uptake of screening. Together, we will ensure that more individuals are screened, ultimately creating better outcomes for people affected by lung cancer.

Accelerating lung cancer screening uptake has long been a key priority of the NLCRT. Since its inception in 2017, the NLCRT has charged many of its strategic priority committees – from Provider Engagement and Outreach to Implementation Strategies – with addressing the challenges that contribute to the low rates of lung cancer screening across the country. The NLCRT has engaged over 200 volunteer experts in multidisciplinary collaborations that aim to drive the national conversation, catalyze action to create, build, and strengthen innovative solutions, and develop evidence-based best practices. Many of these signature initiatives – including the [LungPLAN™](#) resource forecasting model to build and expand lung cancer screening and nodule management programs and our partnership with the American College of Radiology on the 3rd annual installment of the lung cancer screening webinar and podcast series – have recently launched, with other deliverables in progress with key partners. You can read more about some of these initiatives later in the program.

The release of the [President's Cancer Panel Report](#) on lung cancer screening confirmed the value of the NLCRT as a priority cancer control model that effectively and efficiently harnesses the collective power and expertise of the entire lung cancer community to close gaps in cancer screening by connecting people, communities, and systems to improve equity and access. The report concluded that increasing cancer screening rates represents a significant opportunity to reduce the burden of cancer care across the United States, and importantly that the NLCRT is uniquely positioned to lead the lung cancer community in developing and promoting evidence-based cancer screening strategies.

The NLCRT Summit is a critical first step in reducing that burden and reducing it more equitably. At the Summit's conclusion, the NLCRT seeks to:

1. Assure a common understanding of the current state of lung cancer screening, including the challenges and barriers.
2. Identify and prioritize strategies towards developing a multi-year strategic framework to increase lung cancer screening among the eligible population.
3. Engage key partners to explore their roles in fulfilling these priorities as part of the strategic framework.

"The Panel believes that the National Roundtable model provides an ideal framework for bringing stakeholders together and addressing gaps in cancer screening and follow-up care after an abnormal screening test result, including inequities experienced by various sociodemographic groups."

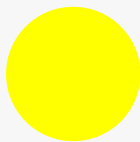

LungPLAN™ Financial Modeling Resource

[LungPLAN™](#) is a free financial planning tool that helps healthcare professionals, financial experts, and administrators model implementation costs and outcomes to demonstrate downstream value of a lung cancer early detection program (screening and nodule management), thereby ensuring these programs are successful and tailored to their patient population. It can be used to build new lung cancer early detection programs (screening and nodule management), as well as strengthen and expand existing programs. All types of facilities - health system networks, academic medical centers, stand-alone facilities, federally qualified health centers, and VA medical centers - can be analyzed, and the metrics adjusted, to increase specificity and applicability to a given facility.

LungPLAN was created by a team of NLCRT clinical, navigation, health systems, and financial experts, and was field-tested by health systems and provides a framework for predicting lung cancer screening and nodule management program costs, resources, staffing, volume, and revenue. It is based on current evidence including data from the American College of Radiology [Lung CT Screening Reporting & Data System](#) (LUNG-RADS) and the [Lung Cancer Screening Registry](#).

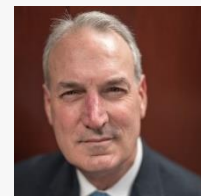
Richard Wender, MD
